Helpful Billing Tips

1. Prior to seeing a patient, be sure to get a copy of the patient's ID card
2. Keep a copy of the ID card, front and back, for your records
3. Call the Benefits and Eligibility phone number on the ID card to:
 - Request eligibility information
 - Determine if the services you will be providing are covered under a patient's particular plan design
 - Ask about any plan design exclusions, billing guidelines, or claims coding rules that may apply
4. Unless prohibited by law, the copayment amount, deductible, or coinsurance may be collected at the time of service
5. Submit clean claims promptly
6. Bill using your usual billed charge
